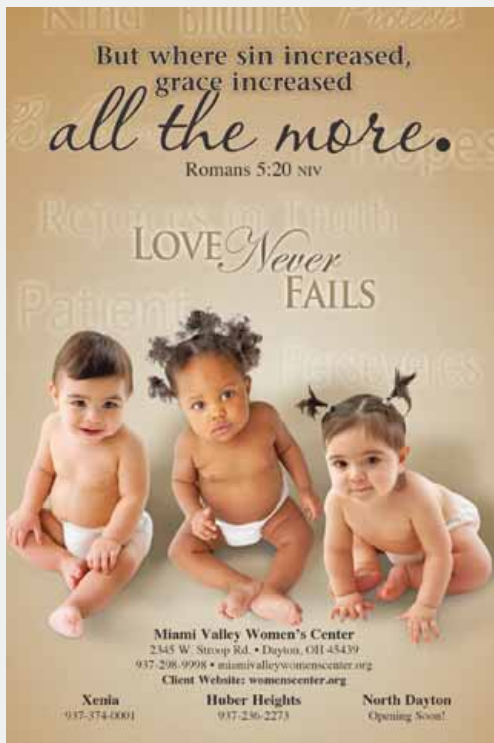

“I Cannot Imagine My Life Without Her”

We came upon the Miami Valley Women's Center because I made a choice to have an affair with someone that was also married. I ended up pregnant and did not want a baby in these circumstances. We live in a small community and the consequence was something I could not face. I could not keep this baby even though I am a Christian. I got the phone book, looked up abortion clinics, and called the MVWC thinking that's what they were. When my baby's father and I arrived, we talked about abortion procedures and different avenues to help us come to a better solution. I cried a lot because I knew the easy choice of an abortion was not an option at this facility, and

I also knew that choice could possibly destroy me. We all prayed together, and they asked if we would like to see our baby via ultrasound. I wasn't ready to take responsibility, but I saw that heart beating. As we left, I was given a flower with what is now my favorite verse: *For I know the plans I have for you, declares the LORD, plans for good and not for harm, plans to give you a hope and a future.* I cried the whole way home because I knew what was right. The flower and verse gave me strength when I doubted my decision. Our sweet Kynlee was born June 6, 2012. **This child who I thought would tear our world up became the glue that bound us all together. I cannot imagine life without her.** If it were not for the influence and mission of the MVWC, my story would not have turned out this way.
