Thank you for your interest in volunteering at the Miami Valley Women's Center. Please complete the volunteer application packet and return it to our Kettering Office to the attention of Karen. Also, please mail your references to the appropriate people, and they can return them to the address listed on the reference form, email or fax them to the attention of Karen. Three references will be required, one from your pastor or church leader and two personal references that are not family members. Please return all paperwork as soon as possible and no later than three weeks prior to the first day of training. I will call you to confirm when all paperwork is received. The director will then call you to schedule an interview. This entire process must be completed before the beginning of the training.

Volunteer training is required for positions that would have client contact. These volunteer trainees will also be required to complete an online training session at home before beginning orientation. As specified in the volunteers opportunities attached, there are some volunteer positions that do not require training, but might have other requirements. We still encourage you to take part of our training opportunity, since you would be blessed with information that supports our pro-life ministry.

STATEMENT OF PRINCIPLE

1. The Miami Valley Women's Centers are an outreach ministry of Jesus Christ through His church. Therefore, the MVWC, embodied in its staff and volunteers, is committed to presenting the gospel of our Lord to women with crisis pregnancies, both in word and in deed. Those who labor as MVWC board members, staff and volunteers are expected to know Christ as their personal Lord and Savior.
2. The MVWC is committed to providing its clients with accurate and complete information about both prenatal life and abortion.
3. The MVWC is committed to integrity in dealing with clients, earning their trust and providing promised information and services. The MVWC denounces any form of deception in its corporate advertising or individual conversations with clients.
4. The MVWC is committed to helping women carry to term by providing emotional support and practical assistance. Through the provision of God's people and the community, women may face the future with hope and plan constructively for themselves and their babies.
5. The MVWC never discriminates in providing services because of race, color, religion, gender, sexual orientation, political affiliation, disability, age, or national and ethnic origin.
6. The MVWC never advises, provides, or refers for abortion or abortifacients.
7. The MVWC offers assistance free of charge at all times.
8. The MVWC is committed to creating awareness within the local community of the needs of pregnant women, and of the fact that abortion only compounds human need rather than resolving it.
9. The MVWC is committed to the healing process of those suffering from the physical, emotional, and spiritual consequences of abortion.
10. The MVWC is committed to promoting God's design for sexuality and supports the biblical concept of abstinence outside of marriage and faithfulness within marriage.
11. The MVWC does not provide counseling for contraceptives or refer its clients for contraceptives or contraceptive services. (Married women seeking contraceptive information should be urged to seek counsel, along with their husbands, from their pastor and physician.)
12. The MVWC recognizes the validity of adoption as one alternative to abortion, but is not biased toward any life-saving alternative. It is independent of adoption agencies, relating to them in the same manner as other helpful referral sources. It receives no payments of any kind from these agencies, does not enter into contractual relationships with them, and does not share combined office space. It neither initiates nor facilitates independent adoption.
13. The MVWC is committed to the practice of non-violent opposition to abortion in both word and deed.
14. All Board members, staff and volunteers are in agreement with and committed to all corporate statements and policies and have signed the relevant commitments.

STATEMENT OF DOCTRINE

We believe Christian unity is a necessity in meeting the needs of our clients and as a visible witness to the community. The Miami Valley Women's Center maintains a position of neutrality regarding church distinctives and avoids espousing any specific denominational viewpoint in these areas. Our volunteers are from various church backgrounds, but all agree on the essentials of biblical Christianity, as expressed in the Statement of Faith of CareNet, and have professed a personal relationship with Jesus Christ.

The presentation of the Gospel through the Miami Valley Women's Center is to be void of church distinctives which may cloud the life and death issue in which we are desperately involved and which might alienate our clients, volunteers, and the supporting Christian community.

Volunteer Opportunities

FINANCIAL SUPPORT: *Provide ongoing or one-time financial support to be used for the ministry of the Miami Valley Women's Center.* Additional information will be available upon request.

The following Volunteer Opportunities require spiritual maturity, commitment and the completion of a volunteer training program. New volunteers will be placed in the positions that best utilize their God given gifts and talents.

CLIENT ADVOCATE:

- Minister to women and men of all ages facing the possibility of an unplanned pregnancy.
- Provide male and female clients with ongoing support and guidance in parenting.

MEDICAL SERVICES: *Use your professional skills to minister to our clients.* This area of ministry requires sonographers, nurses, and physicians who are willing to volunteer their expertise.

CHILDCARE: *Minister to our clients' children.* Assist the Childcare Coordinator in providing a fun environment for the children to learn about Christ. Volunteers must submit an application with references, as well as, undergo a background check.

DEVELOPMENT: Assist the Development department with database and office duties that include pre-event preparations and planning.

GIFT: Serving in the Abstinence department mentoring groups of eighth grade girls meeting during the school day.

The following Volunteer Opportunities do not require the completion of a volunteer training program.

PROFESSIONAL SERVICES: *Use your professional skills to assist in a specialty area.* Donate your expertise such as: social media assistant, photographer, videographer, graphic designer, proof reader, data entry, computer skills, etc. Volunteers must submit an application with references.

ABSTINENCE: *Minister to our middle school and high school groups.* Assist the abstinence department in leading a STARS group by providing refreshments.

PRAYER SUPPORT TEAM: *Set aside a specific time to pray for the Miami Valley Women's Center as a part of a prayer/support network.* Specific prayer needs for clients, the Center's needs and concerns will be provided.

CHURCH LIAISON: *Keep your church informed.* Be the communication link between our development office and your church.

BABY & MATERNITY CLOTHES ROOM: *Organize, sort, fold and hang incoming baby and maternity clothing on a regular basis in preparation for distribution to clients.* Volunteer hours for this project vary. Volunteers must submit an application with references, as well as, undergo a background check.

DONATE: *Provide new or used maternity clothes, baby clothes, baby equipment, etc.* We appreciate donations from individuals as well as churches. Used materials need to be in good condition.

BABY SHOWER, DIAPER DRIVE & BABY BOTTLE BOOMERANG: *Organize small events to provide material assistance and or to raise funds for our clients.* Invite family, friends and/or church to participate.

HANDYMAN/MAINTENANCE: *Use your skills to enhance the functions and professional appearance of the Miami Valley Women's Center.* Work as you are available and needed.

MAILING TEAM: *Join the mailing team to sort, label, and tab special mailings.* This is a two or three hour commitment several times a year.

EVENT TEAM: *Provide volunteer support during our major fundraising events.* Work as you are available and needed.

BAKING TEAM: *Love to bake or provide refreshments?* Bake or buy items for our smaller events.

CLEANING: *Assist in cleaning the Center to keep it attractive and presentable to our clients and community.* Wash windows, vacuum, scrub restrooms, and other general cleaning. Work as you are available and needed.

VOLUNTEER CALL & COMMITMENT

Accordingly, I commit and pledge that:

1. I have accepted Jesus Christ as my personal Savior and Lord.
2. I have read, understand, and I am in full agreement with all of the Corporate Statements and Corporate Policies of the Miami Valley Women's Center (MVWC), including but not limited to, the *Statement of Faith*. I will uphold, accept supervision, and comply with all Policies and Procedures established by the Board of Directors of the Miami Valley Women's Center. **I will not knowingly or intentionally misrepresent the MVWC's policies and procedures and will not speak on behalf of the MVWC without proper training through the Speaker's Bureau of the Development Department.**
3. I believe in the sanctity of human life as taught in the Holy Scriptures. Because human beings are made in the image of God from their earliest moments of existence, I reject abortion as a morally acceptable option of convenience for any pregnancy. Instead, I will offer to women and men visiting the Miami Valley Women's Center accurate information, compassionate emotional support, and spiritual guidance. I agree with the Miami Valley Women's Center policy of not referring a client for an abortion. I will try & convey to each client that I am more concerned about the client than about their final decision, and I will minister to the client regardless of their decision.
4. If I have had an abortion or participated in an abortion (i.e. paid for or accompanied someone, etc.), I understand I am required to complete Abortion Recovery Ministry support group and/or as many one-on-one sessions as deemed necessary by the Abortion Recovery Director before I can attend training.
5. During the time I am a volunteer with the Miami Valley Women's Center, I agree to regularly attend a Christian church.
6. While serving as a volunteer who has client contact, I will not participate in any abortion-related picketing, protesting, sidewalk counseling or rescue. I will not intentionally endanger the MVWC's clients, volunteers, Staff, facilities, or reputation.
7. During the time I am a volunteer with the Miami Valley Women's Center, I will consistently live my life in a way that upholds Christian moral standards, including, but not limited to, refraining at all times from:
 - substance or alcohol over-use or abuse;
 - harassment of any type;
 - child or spousal abuse or neglect;
 - theft, fraud, embezzlement, corruption, bribery, misappropriations, or inappropriate removal or possession of property belonging to the Miami Valley Women's Center, a co-worker, or a vendor;
 - sexual conduct outside the biblical covenant of marriage between a man and a woman;
 - malicious gossip;
 - physical aggression: fighting or threatening violence; etc.
8. I acknowledge the goal of ministering to clients is to honor God as I serve Him. I recognize that God is as interested in transforming my life through the work of the Miami Valley Women's Center as He is in the salvation and transformation of the women and men who come to the MVWC. I recognize that God will use the MVWC to rework the priorities in my life, test, strengthen, and reshape my relationships.

9. I accept responsibility to act as an advocate on behalf of people to whom I minister under the auspices of the Miami Valley Women’s Center without bias or prejudice. Through Christ, I will express an attitude of His love and forgiveness to our clients by word and action. I will keep ALL information concerning clients in STRICT CONFIDENCE, according to the policies of the Miami Valley Women’s Center, including after I leave my volunteering position with the Miami Valley Women’s Center.

10. I promise to minister to each client with wisdom, knowledge, and love of the Lord to help each client to be responsible for his or her actions and to plan constructively for the future. I will be prayerful and open to the Holy Spirit for opportunities to share the Gospel.

11. I commit to:
 - a. Faithfully serve as a volunteer at the Miami Valley Women’s Center, **according to the hours agreed upon with my supervisor. I will provide adequate notice if I am unable to be at my scheduled shift.**
 - b. To attend all required training, including Volunteer Training beginning on _____.
 - c. Complete orientation.
 - d. Attend In-service training sessions, unless excused by my supervisor.

12. I understand completing the MVWC training and orientation process does not guarantee me a volunteer position. I am aware that the final decision is left to the discretion of the Executive Director and Center Director.

13. I understand that volunteers are vital to the ministry of the Miami Valley Women’s Center, that my role at the Miami Valley Women’s Center is completely voluntary and uncompensated, that no expectation of current or future employment is associated with my volunteer role at the Miami Valley Women’s Center, and that my volunteer relationship with the Miami Valley Women’s Center may be ended at any time by myself or the Miami Valley Women’s Center.
